## **PATH UPDATES**

- ➤ PATH Activities Seeking Volunteers The Steering Committee has identified the following activities to pursue this Fall, and we need member input and participation:
  - ✓ <u>Certified Assays</u> -An upcoming activity will be creating a user-friendly version of the list of CDC-certified participants to include on the PATH website. This <u>list</u> is housed on the CDC website, but there are limitations on how the information can be presented and it is very technical. Workgroup members are needed to assist with adapting the list and making it easier for providers, patients, insurers, and researchers to use.   - ✓ Education for Primary Care Physicians During the PATH meeting, the Steering Committee expressed interest in developing a fifth educational module that would be targeted to primary care physicians as part of our educational series on hormone testing. PATH Co-chair Alvin Matsumoto has volunteered to develop an outline and we are looking for volunteers to work with him on the development of this module.
